Scientific Abstract (podium or electronic)

Authorship:

- The presenting author must be a Full, International, Emeritus, or MIT Member in good standing, and must be registered for the Annual Meeting.
- MIT Abstract submissions will only be considered if the MIT application has been approved or submitted by the abstract deadline.
- For accepted podium (oral) presentations, the author must register for the Annual Meeting, and be physically present.
- All MIT podium presentations also require a sponsoring SSR member to be registered for the meeting and physically present for the presentation.
- For accepted electronic (poster) presentations, the first author (and sponsor, for MIT first authors) must both be registered for the Annual Meeting, either as a live participant, or virtually.

Content:

- Abstracts should detail an original scientific research project, adhering to standard principles of IRB approval, informed consent, and disclosure of any commercial interests or conflicts-of-interest.
- All data collection and initial data analysis should be completed at the time of abstract submission. "Promissory notes" with absent or incomplete data will not be accepted.
- Single case reports, with or without a review of the literature will not be accepted as scientific abstracts. Authors may choose to submit them as Case-of-the-Day presentations, if they fulfill the requirements (see COD Guidelines).
- Accepted podium (oral) presentations will be strictly limited to an 8-minute presentation with 7 additional minutes allotted for questions/discussion. Presenters should anticipate being interrupted by the moderator if they exceed their 8 minutes of speaking time to allow adequate time for discussion, and for fairness to the other speakers. Complete instructions for speaker and paper presentation will be provided upon notification of a paper's acceptance.
- Submitted abstracts that are not accepted for podium (oral) presentation will automatically be evaluated for presentation in an electronic poster format. If accepted as a poster, authors will have the option of whether or not to accept the offer to present the abstract in electronic format.
- Authors also have the option to submit abstracts to be considered only for electronic poster format.

Abstract format:

- Title
- Standard scientific sections: Purpose, Materials and Methods, Results, Conclusion (maximum 300 words total)
- (Optional) References (2 maximum, does not count towards word total)
- (Optional) Figures (2 maximum): radiologic image, table, chart, or graphic

Awards:

Young Investigator Travel award: SSR members in good standing who are
within 5 years of completing fellowship or equivalent training OR MIT
members with the approval of their program director may apply. Applicants

- must submit a scientific abstract for the 2025 annual meeting and may not have previously received the award. Click here for additional details.
- Podium presentations are eligible for the following additional awards, which are decided after the Annual meeting: <u>See the SSR web site for award</u> criteria.
 - RSNA Award: Open to RSNA members. Winner is required submit the abstract to the RSNA by their deadline and to present at the 2025 RSNA meeting
 - ESSR Award: Winner is required to present at the 2025 ESSR meeting.
 - ISS Award: Winner is required to present at the 2025 ISS meeting.
 - Patrick T. Liu Innovation in Research Award.
- One scientific poster will be selected for the AIRP Award, which is decided at the annual meeting. See the SSR web site for award criteria.
